## How am I protected?

**Financial companies choose how they share your personal information.** Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully.

## What information can you share?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

**Your Social Security number • Your Credit history • Your Credit scores  
Your Employment information • Your income • Your Assets**

When you are no longer our customer, we continue to share your information as described in this notice.

## With whom can you share it?

All financial companies need to share your personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Equity Atlas chooses to share; and whether you can limit this sharing.

5	How does Equity Atlas protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
6	How does Equity Atlas collect my personal information?	<p><b>We collect your personal information, for example, when you:</b></p> <ul style="list-style-type: none"> <li>• Apply for a loan</li> <li>• Give us your employment history</li> <li>• Give us your income information</li> <li>• Provide account information</li> <li>• Provide your mortgage information</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
7	Why can't I limit all sharing?	<p><b>Federal law gives you the right to limit only:</b></p> <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>• Affiliates from using your information to market to you</li> <li>• Sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

## 8 DEFINED TERMS

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <b>Equity Atlas has no affiliates.</b>
Nonaffiliates	Companies <b>not</b> related by common ownership or control. They can be financial and nonfinancial companies. <b>Equity Atlas does not share with nonaffiliates so they can market to you.</b>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <b>Equity Atlas does not jointly market</b>
